4.1.2 Inspectors must be familiar with the relevant standards or codes used in the inspection activities. 4.1.3 Inspection bodies shall note that qualification requirements of inspectors may be superseded or limited by the regulatory requirements of the countries where the inspection is carried out.

Inspection Body Accreditation

1.1 The purpose of accreditation of the inspection body for site investigation is to ensure the inspection process of site investigation conforms with standards or other normative documents and/or general requirements.

UKAS : Inspection body accreditation

Many types of inspection also involve professional judgement for conformance against standards and general requirements. In all cases, the inspection body must demonstrate that it has the necessary competence to perform the task to achieve IANZ accreditation. There is a close relationship between inspection, testing and measurement.

The general accreditation requirements are stated in two booklets. HKAS 002 contains the regulations. They govern the operation of HKIAS and the duties and benefits of accredited inspection bodies.
