- A system audit is an audit of a system or subsystem against system requirements. It can reveal conformity or nonconformity to the system.
- A process audit is an audit of individual processes against predetermined process steps or activities. It can reveal inefficiencies and areas for improvement.

Audit of the Enterprise Resource

An audit trail or audit log is a security record which is comprised of who has accessed a computer system and what operations are performed during a given period of time. Audit trails are used to do detailed tracing of how data on the system has changed.

The audit process for a computerized accounting system involves five main steps: conducting the initial review (planning the audit); reviewing and assessing internal controls; compliance testing (testing the internal controls); substantive testing (testing the detailed data); and reporting (conclusions and findings).
