According to Government Code 1185(b)(1)(A), a credible witness may be used when a signer does not possess an identification document listed in the statute and it would be difficult or impossible to obtain one.

In Florida, the use of a single credible witness known to both the subject and the notary is authorized under the law. Two credible witnesses must used if the notary does not know them. There is also an affidavit that the credible witnesses sign. This should be kept by the notary.

An affidavit is a written statement, sworn to be true, that can be used as evidence in legal proceedings. You may find that you need an affidavit as a witness to an event or to verify the existence of certain facts, such as the rightful owner of a property, the occurrence of a birth or death, or financial details in business or loan documents.

If you are a California notary public, and you are at a signing where the signer doesn't have a current government issued photo identification document, (or EXPIRED is okay if issued within the last five years) you will not be authorized to notarize the signature of that signer without the use of credible witness(es).

States Allowing One Credible Witness: The credible witness must personally know the signatory and the notary must personally know the witness. This arrangement establishes a chain of personal knowledge such that there is reduced potential for fraud. In these states, the notary should have the credible witness sign an affidavit stating:

Before the oaths are administered, credible witnesses must present valid forms of identification as required by law, such as a driver's license issued by the California Department of Motor Vehicles or a U.S. passport.
