All 50 states require passing of the Engineer-in-Training / Engineering Intern exam, some level of professional experience, followed by passing of the Principles and Practice of Engineering exam, which result in the PE license.

Free PE Exam Course: Traffic Engineering

Since a traffic PE is not required to practice traffic engineering per the "title act" vs "practice act" provision, anyone with traffic engineering experience as described above is qualified to be a reference, regardless of PE status.
