Claim Status | Allianz Global Assistance insurance or file, assist or abet in the filing of a fraudulent claim to obtain payment of a loss or other benefit, or files more than one claim for the same loss or damage, commits a felony and if found guilty shall be punished for each violation with a fine of no less than five thousand dollars (\$5,000), not to exceed ten thousand dollars

(Medical Insurance) claims: Visit MyMedicare.gov, and log into your account. You'll usually be able to see a claim within 24 hours after Medicare processes it. Check your Medicare Summary Notice (MSN). The MSN is a notice that people with Original Medicare get in the mail every 3 months.
