CSRS and FERS: Basic Annuity Computations CSRS Formula— Standard retirement benefits under CSRS generally are available at age 55 with 30 years of creditable service, at age 60 with 20 years, or at age 62 with five years (see Section 5 of this chapter for early retirement eligibility and benefit calculation rules).
