Customary international law arises from the practices of nations when those practices are undertaken out of a sense of legal obligation (called the *opinio juris*). The resulting law is highly decentralized and institutionally undeveloped, similar to the customary law found among subsistence farmers or nomadic tribesmen.

TRADITIONAL AND CUSTOMARY RIGHTS

Customary law can also include provisions for when a water source is shared between different communities, such as the understanding that bathing and washing take place downstream of where drinking water is extracted, for example. Customary practices follow an inherently integrated, holistic approach.
