Fees for these services are based on: Most commonly, fees are based on a percentage of the construction cost. For smaller projects, charges are usually based on an hourly rate or a fixed sum.

Some architects are going to charge an hourly fee while others simply take a percentage of the construction costs. This means if the architect costs 15 percent of the construction cost, and all of the building material is going to cost \$100,000 than the architect receives \$15,000 as a fee.
