**FNMA does not address above-ground pools but FHA does very strongly. Page 16 of Appendix D says "If the sale involves personal property (e.g. above ground pool, lawn mower, furniture, etc.), it should be identified and excluded from the valuation."**

### **Fha Guidelines For Inground Pools**

**FHA Appraisal Requirements for Swimming Pools. In a section entitled "Appraiser and Property Requirements," the FHA handbook states: The Appraiser is required to report any "readily observable defects" that might render a swimming pool inoperable or unusable.**

### **Can a Swimming Pool Drown your Mortgage Application?**

**For functioning pools, the main guidance is: "At minimum, swimming pools, must comply with all local ordinances (perimeter fencing, covers, etc.)..." As you can see, this leaves the research up to the appraiser and the lender to decide what is complying with local ordinances and what is not.**

That's just a fancy way of saying that the appraiser is going to assume all is well.**
