Search for Northampton County Warrants, Pennsylvania (PA ...

The number in front of the name is the warrant number; it is essential for locating the original warrant. Warrants are filed by county, then alphabetically by the first letter of the warrantee's surname, and thereunder by warrant number (e.g., G45 in Fayette County would be the 45th filed in that county for a warrantee whose name started with the letter "G").
