Ethics and Boundaries 2 First Biennium Renewal: Chiropactic Physicians are required to attend one (1) full day at a Florida Board of Chiropactic Medicine meeting within the first 12 months of licensure. Licensees who reside out of the state may satisfy this requirement within (12) months after locating to the State of Florida.
