Businesses will have to record the expense related to the capitalized implementation costs in the same income statement line item as the expense for the fees for the hosting arrangement, the FASB said. U.S. GAAP has required different accounting for services managed in the cloud based on the type of contract a business has with a software provider.

Assessing the accounting for implementation costs for CCAs with multiple modules or components Determine the value of multiple instances of the same hosted CCA service used for different business units or geographies (which could be in different stages of implementation).

Implementation Of Cost Based Accounting  
Under the guidance for implementation costs, a customer that first implements a cloud-based software that is a service would capitalize cost or expense costs by analyzing what stage of the project the costs were incurred during and the nature of the costs.

### Cloud Computing Costs Can Be Capitalized

ASU 2018-15 aligns a customer ' s accounting for implementation costs incurred in a CCA that is a service contract with the requirements for capitalizing implementation costs incurred to develop or obtain internal-use software (and hosting arrangements that include an internal-use software license).
