Medicaid (Title 19) is a wide-ranging, jointly funded state and federal health care program for low-income individuals of all ages.

General Income Requirements for Iowa Medicaid. Medicaid eligibility income limits are based on percentages of federal poverty guidelines. Using the Federal Poverty Level (FPL) from 2009, income limits for emotionally disturbed children are set at 250% of the FPL, or \$2,258 for one person.

Have an income that does not exceed 133% of the Federal Poverty Level Approximately \$15,521 for an individual; Approximately \$20,921 for a family of two (or higher depending on family size) Live in Iowa and be a U.S. citizen; Not be otherwise eligible for Medicaid or Medicare

UPDATE: In 2020, the requirements and application steps for obtaining Medicaid insurance have undergone no significant changes. State officials determine who is eligible for Medicaid in Iowa largely through income and personal requirements. Recently, the expansion of Iowa Medicaid eligibility requirements has increased coverage to more individuals in need of reduced cost health insurance.

When considering income requirements for Medicaid in Iowa, it is important for applicants to remember that Medicaid was developed for low-income individuals and households. Therefore, when establishing income requirements, an applicant's household income is deemed eligible by being compared to the federal poverty level.
