The ISO 14001:2015 standard is significantly different from the 14001:2004 standard in many ways, and the requirements of the environmental policy is one of these differences. Despite the environmental policy being one of the mandatory requirements of the EMS (Environmental Management System), clause 5.2 of the standard does leave some room for interpretation.
