Fur dealers are required to maintain complete recordings for all of the furs they trade or sell and are prohibited from purchasing raw fur of any fur-bearing mammal or nongame mammal from any person who does not hold a valid trapping license, fur dealer license, or fur agent license. A furharvester license is required to trap coyotes, and a hunting license is required to hunt them. The same license required to take coyotes is required to sell their pelts. Unlicensed, non-participating observers may accompany a licensed furharvester but may not carry or use equipment, control dogs, or otherwise assist with furharvesting activities.

Resident Fur Dealer's license application Nonresident An Itinerant (i.e. nonresident) fur buyer's license is required of any person other than a resident fur dealer engaged in the business of buying, bartering, trading or otherwise obtaining raw furs from trappers or from fur buyers or fur dealers in retail lots for purposes of resale.

Furharvest License / Furbearers / Hunting Regulations ...

In order to document harvest totals, interstate fur sales, and total pelt value of the 2018-19 furbearer harvest season, survey forms were mailed to all licensed Wisconsin fur buyers. Fur buyers were asked to report the number of furs purchased from Wisconsin hunters, trappers, other fur dealers, and the number purchased from outside the state.

Licenses, Permits and Registrations

It shall be unlawful for any fur dealer to purchase the raw fur of any fur-bearing mammal or nongame mammal from any person who does not hold a valid trapping license, fur dealer license, or fur agent license. A fur dealer is required to keep a record of the number and kind of all skins or pelts purchased or sold, the place where the skins or furs were killed or trapped, a separate record of all the skins or pelts that were trapped or killed outside Montana, the trapping license number under which the furs or pelts were taken if one was required, the names and addresses of persons to whom skins or ...
