Applicants must be a resident of Pennsylvania to apply. The applicant's household income must meet the requirements set forth by the U.S. Department of Energy (DOE). Every state must set LIHEAP income guidelines each year according to the Department of Human Health Services Poverty Guidelines and State Median Estimates issued on the Federal Register. States must set a maximum income level based on household size and the federal poverty level.

Income Guidelines. The LIHEAP statute establishes 150 percent of the poverty level as the maximum income level allowed in determining LIHEAP income eligibility, except where 60 percent of state median income is higher. Income eligibility criteria for LIHEAP may not be set lower than 110 percent of the poverty.

LIHEAP benefits are calculated on income, household size, the fuel type and the heating region where you live. You must include all people who live your home or apartment and their income. Income eligibility guidelines for LIHEAP are 150% of the federal poverty income level. For example, the income limit for an individual is \$18,735; for a couple, the limit is \$25,365; and for a family of four, it is \$38,625. ELIGIBILITY
