Income & Asset Limits for Eligibility. There are several different Medicaid long-term care programs for which Maine seniors may be eligible. These programs have medical and functional eligibility requirements, although the exact requirements differ, as do the programs ' benefits.

1. MaineCare pays the Medicare Part B premium each month of \$104.90 for you. 2. Automatically qualifies you for Federal Low Income Subsidy (LIS) program. 3. MaineCare pay Medicare ' s coinsurance and deductibles. (You no longer need a Medicare Supplement.) 4. Will also qualify for Maine DEL (Drugs for the elderly)

Income in excess of \$2,313 can still qualify for Medicaid coverage if

excess income is placed into a Qualifying Income Trust (QIT). The trust must be irrevocable and Maine Medicaid must be the designated recipient when the beneficiary dies. Only income in excess of \$2,313 must be placed in the trust.

Maine Medicaid Long Term Care | Eligibility Guidelines 2019

The state ' s waiver proposal requested a work requirement for people up to age 64, premium contributions required if household income is 51 percent of the poverty level or above (for a family of four, that would start at incomes under \$13,000/year), an asset test (with Medicaid only available to people with assets of under \$5,000, as opposed to the current income-based system), and the elimination of retroactive eligibility.

Household income is between 157% FPL and 208% FPL. For households with income less than 157% FPL, children may be eligible for MaineCare without the cost of a monthly premium. How much does it cost? Cub Care premiums range from \$8 per month to \$64 per month depending on household income and household size.

Financial requirements for Medicaid in Maine are outlined below. Children who want to qualify for Medicaid through CHIP or MaineCare must reside in households that earn no more than 213 percent of the FPL, while 19- and 20-year-olds can report earnings no higher than 161 percent of the FPL.
