The revised Annex II, Regulations for the control of pollution by noxious liquid substances in bulk includes a new four-category (X, Y, Z and other substances (OS)) system for noxious liquid substances (See Appendix 1). Vegetable oils which were previously categorized as being unrestricted will now be required to be carried in chemical tankers.

As the 1973 MARPOL Convention had not yet entered into force, the 1978 MARPOL Protocol absorbed the parent Convention. The combined instrument entered into force on 2 October 1983. In 1997, a Protocol was adopted to amend the Convention and a new Annex VI was added which entered into force on 19 May 2005.
