To apply for the Medicaid EHR Incentive Payment Program, Eligible Professionals must first register at the CMS Medicare and Medicaid EHR Incentive Program Registration and Attestation System (R&A). Once registered, they can submit an application and attest online using MAPIR.

MEIPASS: Self-Retractation for Eligible Professionals and Eligible Hospitals. Authorized users may retract a provider's attestation in MEIPASS and resubmit a revised attestation. Providers are no longer required to contact hit@health.ny.gov for manual rejections in order to make changes to submitted attestations.
