Control of Noise Pollution: Laws, Regulations, and Ordinances

A: According to city of Tucker and DeKalb County ordinance, pets cannot vocalize (bark) for more than 15 minutes without interruption or for more than 30 minutes if the noise is intermittent. If the noise occurs during the overnight hours, residents can take audio or video recordings, documenting the date, time and duration.

White noise is a signal (or process), named by analogy to white light, with a flat frequency spectrum when plotted as a linear function of frequency (e.g., in Hz).
