Oklahoma Affidavit Forms Pauper's Affidavit enter This affidavit is to be executed by an affiant stating under penalty of perjury that he or she is without funds or other sources of income to pay an attorney and or to pay the costs associated with a case.

Family Court Forms

A pauper's affidavit is used by a tenant to escape the burden of paying for the court cost associated with an appeal. The affidavit is essentially a statement under oath that the tenant is too poor and incapable of paying a few hundred dollars to the State of Texas. Landlords can contest a tenant's pauper's affidavit.

When you present your pauper's affidavit to the court, the judge will review your lawsuit along with your pauper's affidavit. You cannot file a pauper affidavit by itself, as this would basically amount to a "blank check" that you can use to file whatever you want with the Clerk's office.
