Moving to value pricing - Absolute Certainty

VALUE PRICING VS. VALUE BILLING. Value is defined in economic terms as: The maximum amount that a consumer would be willing to pay for an item. Therefore, value pricing can be defined as the maximum amount a given client is willing to pay for a particular service, before the work begins. This is not to suggest we can capture 100% of maximum value, but rather that we have the potential to access some of it with strategic pricing.
