Mississippi's 2019 withholding formula was released Dec. 19 by the state revenue department. The amount of tax-free income provided in the formula increased to \$2,000 from \$1,000, but the formula's other tax bracket thresholds and tax rates remain unchanged. The standard deduction remains \$2,300 for single individuals.

Withholding Tax Forms - Mississippi

Mississippi law requires withholding of state income taxes from the wages of residents and nonresidents. Residents are subject to the tax for services performed both within and outside of Mississippi. Nonresidents are subject to the tax only on wages paid for services performed within the state.
