1. Zakat. The Zakat (a form of tithe) is paid annually by Saudi individuals and companies within the provisions of Islamic law as laid down by Royal Decree No. 17/2/28/8634 dated 29/6/1370 H. (1950). The Zakat is an annual flat rate of 2.5 percent of the assessable amount.

In determining the tax/zakat profile, the Saudi tax authorities apply a look-through approach to determine whether the upstream shareholding structure at any point exists outside of the GCC. As per the amendment to the by-laws vide Ministerial Resolution No. 1727 on February 10, 2018, in determining indirect ownership the GAZT can look through the structure up to the second level.
