Contents of a Real Estate Disclosure Package

One of those documents is the Seller Property Questionnaire (SPQ). The Seller Property Questionnaire goes into more detail about the property than the Transfer Disclosure Statement. The form's stated purpose is to supply the buyer with "known material or significant items affecting the value or desirability of the property and help eliminate misunderstandings about the condition of the property."
