When class or flag are satisfied with the action taken by the ship owner to close the deficiency, evidence will be provided to RightShip. An inspection usually takes approximately two working days (1 - 1.5 days for Handy size vessels) and a dry vessel inspection will cost approximately US\$7,500 (US\$6,500+/- for Handy vessels).
