As of April 1, 2014 the temporary, shorter stand alone test will no longer be available. Therefore if you want to get licensed in a state that no longer has a state exam requirement you need to get on the ball.

There is no way to enroll for the Uniform State Test until 4/1/2013. Once that date has arrived, you will open a testing window by enrolling through the NMLS system as you would any other test. To my surprise, the NMLS did elect to offer the UST as a stand-alone test for those who have already passed the National Test Component.

Candidate Enrollment Scenarios

A. The ten pre-test (un-scored) questions appearing on the test do not affect the candidate's score or the pass/fail result. These pre-test questions are being pilot tested for future use. Once these pre-test questions are adequately tested, these questions will be considered for use as scored test questions on future NMLS tests.
