A stand-your-ground law (sometimes called "no duty to retreat" law) is a legal justification where an individual can "stand their ground" and use force without retreating, in order to protect and defend themselves or others against threats or perceived threats. Stand your ground allows an individual, who is lawfully permitted to be where they are, to use any force necessary to defend from an imminent threat of serious bodily injury or death.
