The health insurance providers fee applies to all “covered entities,” defined as any entity that has net premiums written for health insurance for any United States health risk during the year. The fee is assessed on health insurers’ premium revenue for health insurance above \$25 million.

Health Insurance Provider Fee: 2017 and 2019 Moratoriums – Questions and Answers. A5: The 2017 and the 2019 moratoriums have no effect on the filing obligation or fee amount for the 2018 fee year. The “applicable amount” for fee year 2018 remains at \$14.3 billion (see Treas. Reg. § 57.4(a)(3)).

Health Insurance Providers Fee

This fee on health insurers (including HMOs) starts at \$8 billion in 2014 and then increases year after year before reaching \$14.3 billion in 2018. After 2018, it will continue to increase with premium growth. The fee was suspended for the 2017 and 2019 calendar years.

Federal Register :: Health Insurance Providers Fee

One of those is the Health Insurance Provider (HIP) Fee, which first took effect in 2014. The HIP Fee applies only to health insurers. It is intended to help fund federal and state-run Marketplaces (Exchanges). The fee amount is an allocation among
