Responsibility of International Organizations

The conduct of an organ or agent of an international organization in the performance of functions of that organ or agent shall be considered as an act of that organization under international law whatever position the organ or agent holds in respect of the organization.

A duty to protect heads of state visiting an international organization, for example, will typically rest on the host state of the organization, rather than on the organization itself, and much the same applies to a duty to protect permanent representatives of states or organizations or the headquarters of organizations. 93 Moreover, it is doubtful whether there exists any duty to implement treaty commitments into the internal legal order of the organization.

In 2011, the International Law Commission (ILC) adopted a set of draft articles on the responsibility of international organizations (IO Responsibility Articles).
