According to Article 1 (d) URDG 758, where a demand guarantee or counter-guarantee issued after 1 July 2010 states that it is subject to the URDG without stating whether the 1992 version or the 2010 revision is to apply or indicating the publication number, the demand guarantee shall be subject to the URDG 2010 revision.

Uniform Rules For Demand Guarantees (URDG)

URDG 758 also recognizes the guarantor's potential role of being in the middle of a dispute between the beneficiary and the instructing party. The guarantor to, without delay, notify the instructing party of any demand to extend the guarantee (Articles 16 and 23).
