There are many guidelines that can be followed to plan open spaces in urban areas like the LEED ND (Leadership in Energy and Environment Design Neighborhood Development). According to established best practices, the green area per capita should be >20 m² which translates into a minimum of 1.25 ha open space per 1,000 residents.
