License holders must be licensed for the specific vehicle type and line-make displayed or sold, and include manufacturers, distributors, converters, and dealers depending on the vehicle type. License holders who are not legally authorized to sell a new motor vehicle at shows or exhibitions may only display a Manufacturer's Standard Retail Price (MSRP) or a Monroney label or sticker in or near each vehicle.

Designated Agent Qualification Requirements: Licensed Alabama Motor Vehicle Dealers must have a current Dealer License. Licensed financial institutions – Submit a copy of their Title 5, Chapter 19, State Banking License or equivalent. Pawnshops – Submit copy of Alabama Pawnshop License.
